## **Types of Data collected**

Among the types of Personal Data that this Application collects, by itself or through third parties, there are: **Cookie and Usage data.**

## **Mode and place of processing the Data**

### **Methods of processing**

The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated.
